1. Ownership of App; Agreement to Terms of Use

These Terms and Conditions of Use (the "**Terms of Use**") apply to use of the SnappArt subscription (the "**App**"). The App is the property of INVE Technologies NV and its affiliates ("**ITECH**").

The Terms of Use apply to the App in addition to any additional payment terms which you have selected in the process of subscribing for the App (the "**Payment Terms**"). In the event of any discrepancy between these Terms of Use and the Payment Terms, these Terms of Use shall prevail.

BY USING THE APP, YOU AGREE TO THESE TERMS OF USE; IF YOU DO NOT AGREE, DO NOT USE THE APP.

ITECH reserves the right, at its sole discretion, to change, modify, add or remove portions of these Terms of Use, at any time.
